11. Bedok Reservoir Operations

- a. With safe distancing measures still in place, a friendly local "pop-up" competition was held on 23 April, 2022 to energise and bring the waterski community together.
- b. PUB conducts quarterly safety audits and constantly reviews our Standard Operating Procedures. They have asked us to look into building a permanent gangway with security gate.
- c. Owing to feedback from residents in the condominium nearby, PUB has asked us to take measures to reduce the noise emissions from our speedboat. After due consideration and research, Bedok Waterski Committee moved the slalom course 50m away from the end closest to the condominium.
- d. PUB has also been pressuring us to have the Jump Ramp reinstated to working condition, or removed.
- e. Revenue from Bedok Waterski Operations amounted to \$\$5,330.65 (diff between the \$500 agreed monthly rate was due to the repair period for the Prostar from August to November, and closure of Bedok to ski ops for 10 days to waterskiing in May due to Wakefest preparation, competition and reinstatement.)
- f. The Prostar was off the water for a couple of months for the agreed repairs to the hull and for engine overhaul. The Total cost of the repair was \$24,337.
- g. We finalised the agreement between SWWF and Trilogy for Bedok Operations and confirmed the committed \$500 monthly rental fee payable to SWWF, notwithstanding that Brian Peace has also now made available his new boat, a Malibu, to operate alongside the Prostar. This gives us a back-up boat (useful in the period when the Prostar was awaiting a new replacement part and could not be used) but does not affect the monthly rental.
